

RWY 06/24 - RWY end turning nodes - all turns must be MNM speed MAX RAD.

FLIGHT PROCEDURES

ACFT to avoid flying over mine pit.

CTAF - AFRU 126.8

AFRU signal not AVBL on ground Laverton, Murrin Murrin or Sunrise Dam. AFRU located at Leonora.

ADDITIONAL INFORMATION

1. Bird Hazard in VCY of AD (falcons or hawks).
2. Animal hazard (kangaroos). ARO will conduct additional RWY inspection prior to scheduled ACFT OPS.
3. Seasonal wetlands may be present at western end of RWY, ducks, swans and birds of prey maybe in VCY.
