PERTH AIRPORT (YPPH) FY23 AIRFIELD PAVEMENT RENEWAL WORKS

1. INTRODUCTION

- 1.1 This AIP AIC cancels and replaces AIC H50/23, with amendments to work methodology for rectification works on Taxiway Romeo and start and finish dates.
- 1.2 This AIC is also to provide works progress update and further notification of the airfield pavement renewals and surface treatment works planned for FY23. Works will be staged to minimise disruption to operators.
- 1.3 All works disrupting aircraft operations have been advised via distribution of the Method of Working Plan (YPPH 003/23) provided on the Perth Airport corporate website:

- 1.4 The actual date and time of works will be advised by a NOTAM.
- 1.5 Pavement surface renewals are planned for:
 - Taxiway Romeo and Romeo aircraft parking positions SO03 – SO14
 - 500 Lane between Link 3 and Hotel Lane

2. WORKS PROGRAM

- 2.1 **Closures for 500 Lane between Link 3 and Hotel Lane** are proposed to be between 1200-2100 UTC with closed areas being made available at the end of each works shift.
- 2.2 The works have commenced in September 2023 and are planned for completion in April 2024.

- 2.3 The main works on T1 Taxilane (behind Bays 151A to 149), Gate 14 Road, Taxiway Bravo, Taxiway Romeo, Taxiway Charlie and 500 Lane were completed.
- 2.4 Some rectification works required on 500 Lane and Taxiway Romeo. These works are planned in February 2024 and will be completed in April 2024.
- 2.5 Rectification works along Taxiway Romeo will be located outside of the graded portion of this taxiway and will not require closures, but some aircraft restrictions will apply. These restrictions will be provided in the updated MOWP YPPH 003/23.
- 2.6 Bay closures for surface treatments will be coordinated with Perth Airport ACC.

3. OPERATIONAL INFORMATION

- 3.1 Airfield ground lighting in the affected areas will be unavailable for the whole works period within each individual stage.
