**MILITARY EXERCISE, ARCHER 2025
EAST AUSTRALIAN EXERCISE AIRSPACE,
27 JUNE - 02 JULY 2025**

1. INTRODUCTION

- 1.1 Elements of the Australian Defence Forces will be conducting live fire training activities in the Naval East Australian Exercise Airspace (EAXA) off the coast of Nowra, over the period 27 June – 02 July 2025. In order to support the safe execution of Exercise ARCHER 25, TMOA ‘BOUNTY’ has been established on the eastern edge of EAXA permanent airspace to segregate military activities from non-participant aviation activities.
- 1.2 This AIP SUP describes the airspace, timings, flight planning requirements, access and procedures associated with this activity.
- 1.3 Delays to civil aircraft in transit may be experienced.

2. AIRSPACE – EAXA (TSX)

- 2.1 During the activity it is expected that all of the following permanent EAXA restricted areas will be activated:

- 2.2 The following Temporary Military Operating Area (TMOA) is established in addition to permanent restricted areas for this activity (Refer Appendix 1):

TMOA ‘BOUNTY’

Lateral Limits: 351859S 1525550E – 364021S 1542755E – 372712S 1532546E – 375925S 1505416E – 365643S 1504503E then along the counter clockwise arc of a circle radius 120.00NM centre 345700S 1503200E (UXUTI/WPT) – 351859S 1525550E

Vertical Limits: SFC - UNL

Hours of Activity: NOTAM

Administering Authority: Fleet HQ Potts Point

3. AIRSPACE ACTIVATION

- 3.1 The airspace outlined at Section 2 is expected to be activated for the following periods for the execution of Exercise ARCHER 25:

DATE	TIME
27 June 2025	0800 – 1700 Local (2200 – 0700 UTC)
30 June – 02 July 2025	0800 – 1700 Local (2200 – 0700 UTC)

- 3.2 Extant EAXA airspace may be activated at any time for activities not associated with this activity.

3.3 NOTAM

- 3.3.1 EAXA (TSX) and FIR (YBBB/YMMM) NOTAMs will be issued to confirm activation timings. Timings may be amended or airspace deactivated by NOTAM at short notice.
- 3.4 Activation of EAXA airspace and TMOA ‘BOUNTY’ in support of this activity will specifically refer to this SUP in the NOTAM.
- 3.5 NOTAM will be issued at least 24 hours prior to expected activation.

4. FLIGHT PLANNING

- 4.1 There are no published air routes that are affected by TMOA 'BOUNTY'.

5. ACCESS TO EAXA AND TMOA 'BOUNTY' AIRSPACE

- 5.1 When active and in use, access to EAXA RA and TMOA 'BOUNTY' by non-participating aircraft is not available except for aircraft with a declared emergency or participating in activities for the preservation of life and property (MEDEVAC, FFR, POL, SAR)
- 5.2 Aircraft requiring access to active EAXA RA or TMOA 'BOUNTY' are to contact BN CEN for clearance.

- 6.1 This SUP self-cancels at 202507020700 UTC.
