**MELBOURNE AIRPORT (YMML)
COMMISSIONING OF TWY D AND
ASSOCIATED WORKS****1. INTRODUCTION**

- 1.1 This AIP SUP cancels and replaces SUP H139/25 with the amendment to the email address and Appendix 3.
- 1.2 This AIP SUP details Stages 7, 8 and 9-11 of TWY works at Melbourne Airport (YMML).
- 1.3 New TWY D was commissioned on 08 APR 2025 to improve capacity and operational efficiency at Melbourne Airport.
- 1.4 Stage 7 completion triggered the opening of TWY D. Stage 8 is the closure of TWY A and TWY E intersection. Stage 10 is the realignment of TWY E.

2. WORKS PROGRAM

- 2.1 Works will be carried out in accordance with MOWP Taxiway Zulu YMML 2024/1. Main stages are summarised below. For all stages, refer to the MOWP.
 - 2.1.1 Stage 7 (completed)

TWY D was commissioned parallel to RWY 09/27 between TWY P and V on 08 APR 2025. Refer Appendix 1.
 - 2.1.2 Stage 8

Intersection closure of TWY A and E allowing for early works in preparation for TWY E realignment on 09 APR 2025. Refer Appendix 2.

2.1.3 Stages 9 to 11

TWY E realignment between TWY P and V. TWY E is scheduled to close on 23 AUG 2025 with an expected return to service of 20 JUN 2026.

3. OPERATIONAL IMPACT

- 3.1 The full length of TWY D accommodates Code E ACFT with a MAX wingspan of up to, but not including 65M, and up to, but not including 15M outer main gear wheel span.
- 3.2 Effective on publication of this SUP, TWY D between TWY A and V has been upgraded to a Code F TWY. TWY D between TWY A and P will be upgraded to a Code F TWY at the completion of all stages of work.
- 3.3 The full length of TWY D is available for use in RVR conditions of less than 350M (CATII/CATIII). Refer Appendix 3.
- 3.4 Approved Taxi Routes
 - 3.4.1 Taxi Routes published in DAP – TWY D between TWY A and P not available for B748 and A380, refer Appendix 5 and 6.

4. CANCELLATION

- 4.1 This SUP will be cancelled when it is incorporated into AIP, expected 27 NOV 2025.

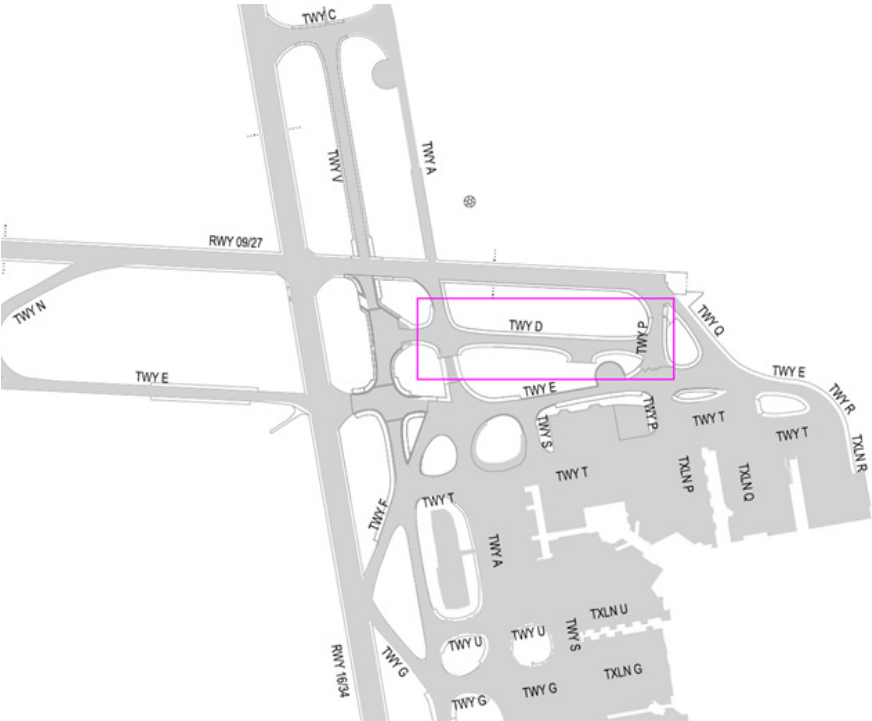

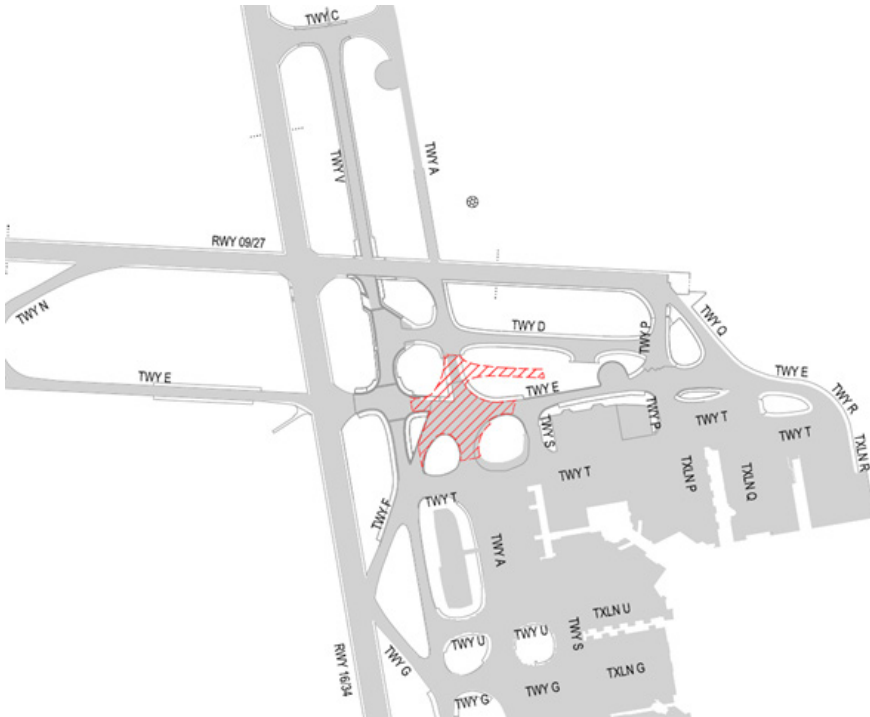

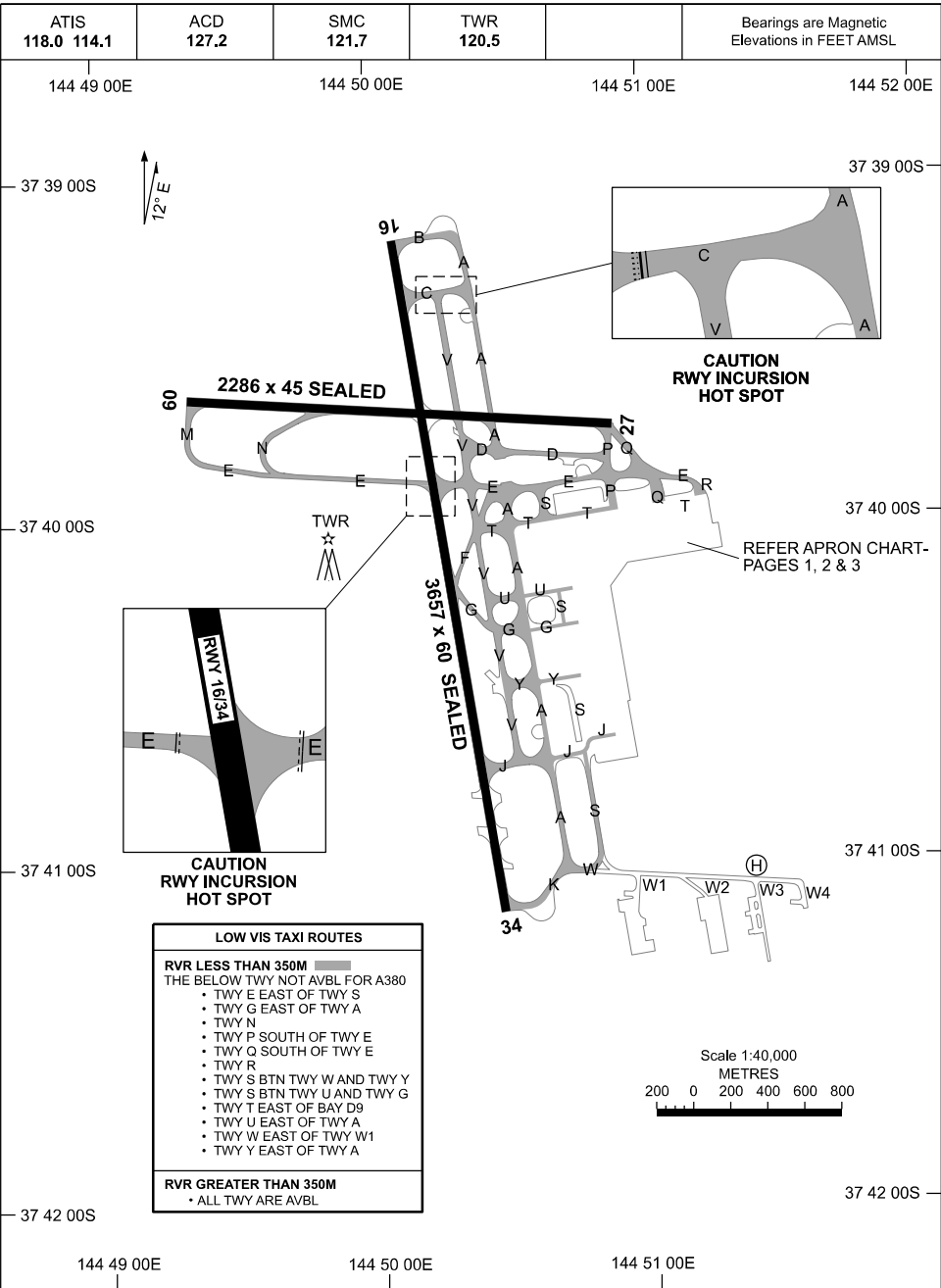

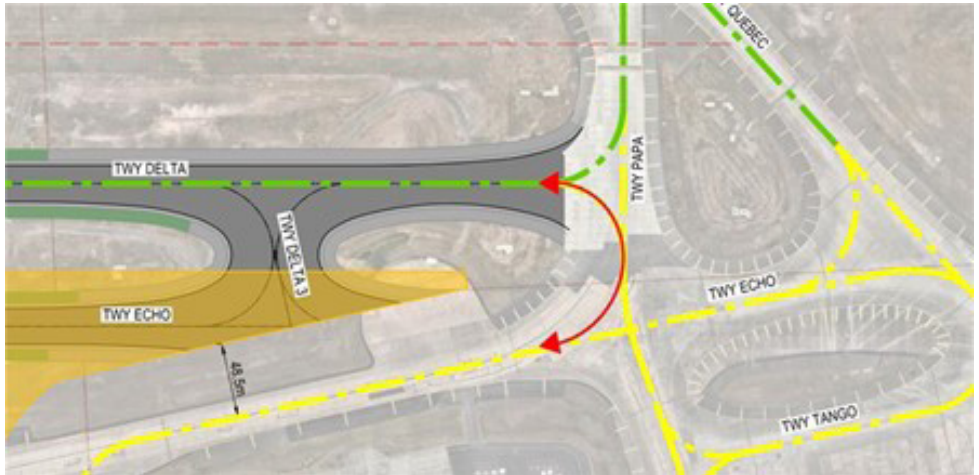


2. TWY A and E Intersection Closure - Stage 8



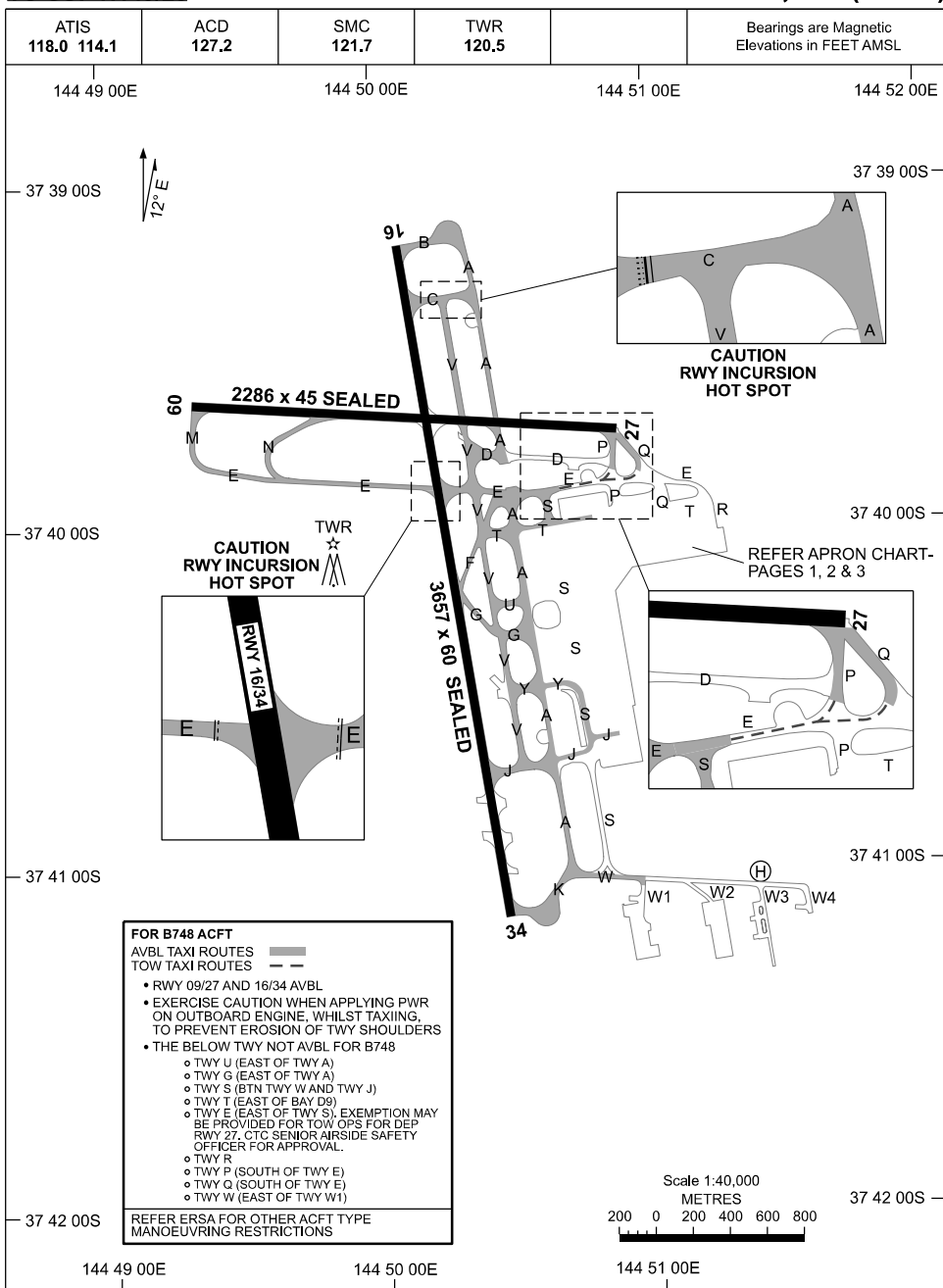

AERODROME GROUND MOVEMENT CHART - Page 1 MELBOURNE, VIC (YMML)

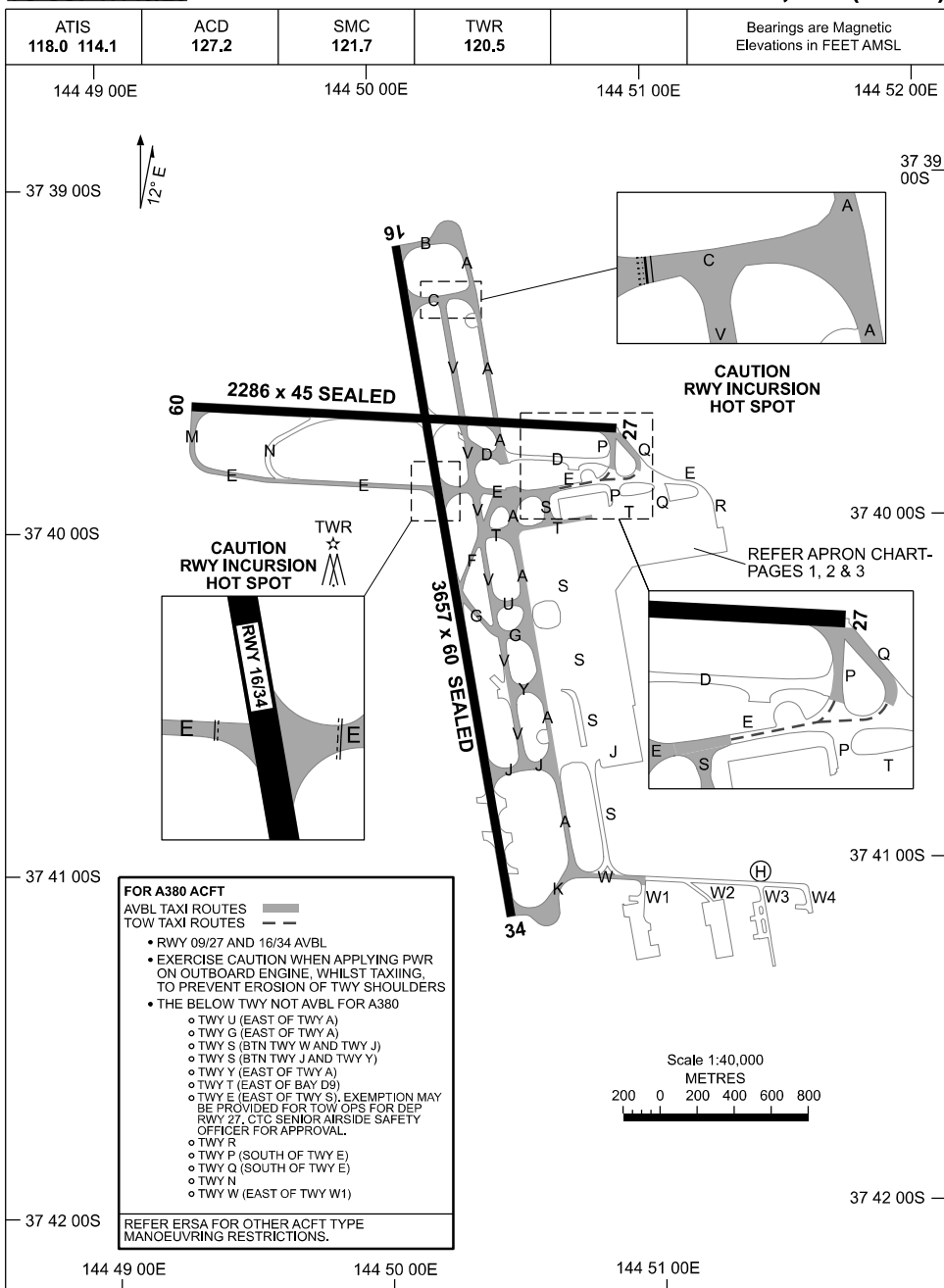
