# MILITARY EXERCISE 'BLACK DAGGER 2025' AND 'NORTH QUEENSLAND WARFIGHTER FIELD TRAINING EXERCISE 2025' TOWNSVILLE FIELD TRAINING AREA 12 MAY – 12 JUNE 2025

# 1. INTRODUCTION

- 1.1 Elements of the Australian Defence Force (ADF) will be conducting military exercises, Black Dagger 2025 (BD25) and the North Queensland Warfighter Field Training Exercise 2025 (NQ WFX 25) within existing Townsville Field Training Area (TFTA) permanent restricted areas and Temporary Restricted Areas (TRA) in the vicinity of Charters Towers Aerodrome (YCHT) over the period 12 May 12 June 2025.
- 1.2 During certain periods, some TFTA airspace volumes will only be partially activated to avoid activating large portions of airspace not required for NQ WFX 25.
- 1.3 This AIP SUP describes the TFTA airspace and TRA associated with these activities.

# 2. AIRSPACE

2.1 During the exercise period all, or some, of the following permanent and temporary restricted and danger areas will be activated, with vertical limits to be published by NOTAM.

2.2 The following permanent TFTA Restricted and Danger areas will be activated, with vertical limits and hours of activity published by NOTAM (refer to Appendix 1):

#### 2.4 **NOTAM**

Airspace users should refer to the local area (TLX) and Brisbane FIR (YBBB) NOTAM to confirm vertical limits and activation timings for permanent airspace and TRA. Timings may be amended or deactivated by NOTAM at short notice. Anticipated TRA activation timings are listed in the following table:

- 2.5 Activation of TRA or partial activation of permanent TFTA Restricted and Danger areas in support of NQ WFX 25 will specifically refer to this AIP SUP in the NOTAM.
- 2.6 NOTAM will be issued at least 24 hours prior to expected activation.

# 3. MILITARY AIRCRAFT OPERATIONS

#### 3.1 Charters Towers region

- 3.1.1 YCHT RNP RWY 24 Approach will not be available while TRA 'FENRIR' is active. The affected procedure will be promulgated as unavailable by NOTAM.
- 3.1.2 Aircraft conducting the YCHT RNP RWY 06 Missed Approach are required maintain not above the 25NM MSA until laterally clear of TRA 'ALLEY'.

# 4. ACCESS TO EXERCISE AIRSPACE – CHARTERS TOWERS REGION

4.1 In all circumstances, the Controlling Authority will facilitate access to aircraft with a declared emergency, participating in activities for the preservation of life and property (SAR, MED, POL or FFR).

#### 4.2 TRA 'FENRIR'

4.2.1 Should transit of TRA 'FENRIR' be required, access must be obtained from the Controlling Authority prior to entry. The underlying Class G services will apply.

#### 4.3 **TRA 'ALLEY'**

- 4.3.1 Should transit of TRA 'ALLEY' be required, access must be obtained from the Controlling Authority prior to entry. The underlying Class G services will apply.
- 4.4 Access to the restricted area by non-participant aircraft will generally not be available except for:
  - a) Aircraft operating in the preservation of life or property (MEDEVAC, FFR, POL, SAR).
  - b) Aircraft with a declared emergency.
  - c) Aircraft that pre-arrange clearance with the Controlling Authority by phone prior to take-off.
- 4.5 No ATS will be provided to aircraft requiring transit of TRA 'FENRIR' or TRA 'ALLEY'.
- 4.6 Should a flight noted above require transit of TRA 'FENRIR' or TRA 'ALLEY', contact with the Controlling Authority before departure is required to ensure that transit is available. When airborne, contact is to be made with the Controlling Authority on 126.7 to request transit clearance prior to entry.




