NEW SOUTH WALES, 09 - 25 MARCH 2026****1. INTRODUCTION**

- 1.1 This AIP SUP cancels and replaces H19/26 with an amendment to the table in para 2.5.1 and correction to para 5.6.
- 1.2 Elements of the Royal Australian Air Force will be conducting Exercises ‘ACES ALPHA 2026’ (AA26) and ‘DIAMOND SHIELD 2026’ (DSD26) over the period 09 – 25 March 2026.
- 1.3 This AIP SUP describes the airspace, timings, diversion routes and procedures associated with these activities.

2. AIRSPACE

- 2.1 Two separate airspace configurations will be utilised between 09 – 25 March to facilitate exercise activities. These two configurations, AA26 airspace and DSD26 airspace, have been devised to provide clarity on the lateral boundaries of activated airspace and the associated diversion routes for non-participant aircraft.
- 2.2 Airspace users should refer to Amberley Airspace (AMX and AWX), Williamtown Airspace (WWX) and Brisbane FIR (YBBB) NOTAM to confirm vertical limits and activation timings, for permanent airspace and temporary special use airspace.

2.9 NOTAM

- 2.9.1 Airspace users should refer to both local area (AMX, AWX, WMX and WWX) and Brisbane FIR (YBBB) NOTAM to confirm vertical limits and activation timings for permanent and temporary SUA. Timings may be amended or deactivated by NOTAM at short notice.
- 2.9.2 Activation of TRA in support of AA26 and DSD26 will specifically refer to this SUP in NOTAM.
- 2.9.3 NOTAM will be issued at least 8 hours prior to activation.
- 2.9.4 General airspace enquiries prior to exercise start can be made to the Joint Airspace Control Cell on (02) 6128 4856 during normal business hours (AEDT) or via email adf.airspace@defence.gov.au.
- 2.9.5 During execution, contact the Exercise Airspace Manager on (02) 6250 6671.

3. MILITARY AIRCRAFT OPERATIONS

3.1 Noise sensitive areas

3.1.1 Military aircraft will plan to avoid known sensitive areas and comply with Fly Neighbourly Advice.

4. ACCESS TO EXERCISE AIRSPACE

4.1 Access through active restricted areas described in this SUP, by non-exercise aircraft, is not available except for:

- a) Aircraft operating in the preservation of life or property (SAR, MED, POL, FFR), and
- b) Aircraft with a declared emergency.

4.2 Should priority transits IAW with para 4.1 be required, airways clearance must be obtained from the Controlling Authority prior to entry.

4.3 No ATS will be provided to civilian aircraft requiring emergency transit of Exercise Airspace.




