

Meeting Summary

Discussion

Members discussed:

- The suitability of the Uncrewed Services Advisory Network (USAN) name; in particular, the use of the term 'uncrewed', as some Advanced Air Mobility providers will have crewed operations. There was discussion that the name may need to capture the network's long-term direction.
- International activities and the importance of visibility on discussions and outcomes of international forums to help inform the USAN.
- Airservices' written answers to the questions posed in meeting one.
- The need to be informed about Airservices' investment pipeline for Uncrewed Services, including identification of the core challenges and/or needs being addressed by new services, the benefactors of such new services, and the potential for any costs to utilise the services.
- The need for engagement with potential UAS Service Suppliers (USS) looking to connect to the Flight Information Management System (FIMS) and the need for USSs to achieve a return on investment.
- The opportunity for industry to co-design with Airservices the concept of operations for USSs in Australia.
- A need for a centralised dataset from Airservices and the timeline for its availability. There was discussion that the USAN is an important mechanism to allow industry to provide input and guidance to Airservices on its priorities and services development.
- Several USAN members noted that they were engaged in the Aviation Green paper consultations and that the request from members in meeting one to provide feedback to Airservices for potential inclusion in its Green paper submission was no longer necessary.
- Airservices provided an overview of Automated Airspace Authorisations (AAA) and advised that AAA will be the first capability rolled out under FIMS in 2024. The members resolved to create a working group (WG) under the USAN to review and provide advice about the rollout of AAA and the introduction of USSs into the Australian UTM market, with the specific WG tasks and timeline to be defined.

- The timeline Airservices working to for delivery of datasets, how accessible the datasets will be, and information about privacy and security matters
